## The North Country Supports Drum as Interceptor Site Kevin Jordan, Chair, FDRLO Missile Defense Task Force

he FDRLO took no chances in helping show community support for the proposed Missile Defense Project. In an effort to ensure that the Missile Defense Agency (MDA) and any other decision makers responsible for site selection know how strong the support is for this project at Fort Drum, the FDRLO helped energize the community into responding. After the scoping meeting held on June 28 at the Carthage High School, and in working with Congresswoman Stefanik's office, it became apparent to the FDRLO that part of what the MDA was assessing for site selection during the **Environmental Impact Statement** public comment period was the degree of public support for the project at each of the 3 proposed locations, Fort Custer Michigan, Camp Ravenna Ohio and Fort Drum New York.

Like the FDRLO has done so many times in the past, it once again organized its many volunteers and put a plan in place to respond to a defense related issue needing the communities' attention. Not unlike the March 20, 2015 SPEA Rally and Listening

Session, the FDRLO organized, implemented and continually assessed progress. Unlike the SPEA process, however, which allowed for almost 6 months to plan and respond, the MDA **Environmental Impact Statement** (EIS) process only allowed for 45 days for public comment. While that time was later extended by 30 days, it was still a fraction of the time allowed compared to the SPEA process. A key part of getting the word out this time included quickly educating the public about the significant benefits the project would have on the economy if it was built. After all, when would this community have another chance at creating 600-800 new wellpaying permanent jobs, \$3 billion in upfront investment and an additional \$27 million into the local economy annually?

The process started with the various media outlets assisting by running repeated public service announcements. The FDRLO developed and provided an online petition on its website for individuals to sign. In addition, the FDRLO staff and volunteers attended numerous events during this 45 day period to garner signatures with hard copy

petitions. A letter writing campaign was also implemented to get a strong response from the business community. This was accomplished with the help of the various Chambers of Commerce and direct contact with businesses. Another important component of the community response included letters from various community experts correcting and clarifying information and assumptions outlined in the draft EIS that the FDRLO considered incorrect or incomplete. These included letters about infrastructure, available labor force, housing, transportation, education, and health care. It even included letters from local and State leaders explaining the

and past experience in assisting with large scale projects supporting the Army and Fort Drum. Although this would seem obvious to the Army, the MDA has had no experience with our community and as a result outlining the communities' abilities in assisting with projects of this size was considered an important component. In the end, the FDRLO's plan got the results we needed. The North Country community rallied and responded within the required time providing over 7,000 signatures, as well as 193 letters and resolutions from businesses. organizations and municipalities in support of a Fort Drum Missile Defense project.

Now we are in that waiting period that the community has so often experienced in the past with important defense projects effecting our community. We should all hear later this fall what preferred site the MDA has recommended. While we are awaiting that decision, we can rest assured that the community has once again shown its dedication as a strong military partner here at Fort Drum!


#### Mission:


